**Funding Requests** – Coach Wertz submitted a funding request for a funding request for \$1155 for Javelins for Track and Field. The team had a few break due to wear and tear. Dave researched and prices for items submitted seem good. The team has refurbished in the past but need to order four additional for the season. Team does a "fund my friends" request to fund their program but most goes to fund coaches. 180 kids in Track and Field. Lindsey moves to approve. Traci seconds. Motion approved.

Prairie Ridge Elementary 5<sup>th</sup> Grade Farewell – request for Mill Valley Swag. Team discussed and this is not something we have access to so we will not be able to act on this request.

Fighting Fentanyl 5K – request for sponsorship. MV student, Cooper Davis' family is running this event in honor of him. All proceeds go to the Cooper Davis Memorial fund to raise awareness of the dangers of Fentanyl. **Financial Report** - Matt presented the financial report, current balance is \$30,636.70 with a net income for March of -\$1513.27. Traci moved to approve the financial report, Tyler Jones seconded. Motion passed.

**Awards & Recognition** – We are waiting on Band, Forensics and Choir to hear what we have upcoming for awards and recognition. Scholarships are with the judges currently.

**Membership** – No new updates. Discussed having a meeting to handoff from Ryan to new Membership Chairs to discuss ideas for the coming year. Ryan will meet with the new committee members to facilitate the handoff.

Concessions – We have had an ongoing debate with Coke on our prices. In the past, we have had an issue with invoices where the prices invoices are different than the agreed upon pricing. This is based upon the district pricing; we don't have input or access to the information currently but will investigate this.

They are now wanting us to pay different pricing; \$22/case (up from \$19/case) but not \$26/case which was the pricing earlier this year. We have an \$1800 outstanding balance for the year that we need to determine how we will settle. We may also want to keep an eye on pricing if costs continue to rise. We are currently charging \$2/bottle. Raising to \$2.50 causes us to have to deal with change, etc.

We don't have to use Coke products, but we would have to enter into a new contract and look at District requirements. They also provide our coolers, which we'd have to swap out, etc. We could look at the prices the Catty Shack and the DeSoto concession pricing to determine how our prices compare.

Mark and Tyler will look into this further with the district and report back.

Dave Twigg will meet with the upcoming Concessions committee with Matt at the Concession and share notes.
